The Tribunal is an independent body that protects the rights of people receiving involuntary treatment for mental illness. It provides an independent review and makes decisions about whether the treatment will be given in hospital or in the community. In making these decisions, the Tribunal must balance the rights of the patient with the rights of others and the protection of the community.

If you are unhappy with the decision of a Mental Health Review Tribunal hearing, an appeal of the decision can be lodged with the Mental Health Court by contacting the Mental Health Court
